# Zone 4 Club Registration

Now is the time to renew your Club membership with CCSAM on <u>https://zone4.ca</u>. Use your login ID & password and click "Join a Division" in your Club Settings window. If you need any help with this, please contact me or the helpful Zone4 people.

If you are a NEW club this year (or if you have not yet signed up with Zone4) you will need to create a free account with Zone4. Use this link for instructions: <u>http://help.zone4.ca/kb/guide-for-clubs-new-to-zone4-registrations/</u>

Zone4 is where you will maintain your club membership database. You are strongly encouraged to have your members join your club via a Zone4 membership registration form that you create online. If you don't know how to do this, contact Zone4 support, they are very helpful and can get you set up in a matter of minutes.

Note: ALL members must be uploaded to the Zone4 database. There is still an option for clubs to manually upload their members (rather than have members do this themselves) but there is a \$1 charge (to the Club) for each member manually uploaded.

## Liability Insurance

Our insurance provider requires each club to submit, to the CCSAM office, a complete list of the club's **scheduled club events & activities** – e.g. weekly Jackrabbit program, ski trips, learn-to-ski sessions, team training etc. Events that are published on the CCCSAM website (Division sanctioned events) are automatically included as sanctioned activities with our insurance provider. A great way of sharing your club event/activity list is by creating (and sharing) a Google Doc with



info@ccsam.ca. This way any changes or last minute additions to your schedule are automatically submitted.

Our policy covers **Additional Insureds**. If you have a land owner or business or anyone that requires being named as an additional insured on our liability policy please check the current spreadsheet (link below) for accuracy. To add someone, please email me with full legal name and address of each person/entity.

Please remember ALL members of your club need to be registered with CCSAM in order to be included in the insurance policy. This includes all of your officials and coaches and volunteers working with your Jackrabbits and other club programs/activities.

Please know that we must adhere to Nordiq Canada's <u>Minimum Mandatory Coaching Qualifications</u> policy and understand there are liability insurance implications associated with this policy. As well, please instruct your active coaches to register annually for a <u>Nordiq Canada Coaching License</u>.

All club members must sign the **Informed Consent and Assumption of Risk Agreement**. This is a pre-set field in Zone4 that you will add to your club registration. If you are using paper forms and uploading your members manually to Zone4 than please make sure you keep signed copies of the Informed Consent and Assumption of Risk Agreement from each of your members. Please note that all event participants must also sign this agreement as a condition of their participation in any event. Exceptions are members (who have signed already) but if in doubt get them to sign anyway.

If you are a NEW club with CCSAM, please be sure to submit a **Directors & Officers Liability Insurance** (Non-Profit D&O) application in your first year.

## Important Policy Updates

In 2023, Nordiq Canada and its Divisions have adopted a Pan-Canadian approach to Safe Sport. Beginning in April 2024, all Divisions and Clubs will agree, as a condition of their Nordiq Canada membership, to formally adopt and implement a suite of common safe sport policies. Nordiq Canada will provide templates for these policies to all Divisions and Clubs, namely:

- Code of Conduct and Ethics
- Discipline and Complaints
- Safe Sport
- Athlete Protection
- Event Discipline Procedures
- Screening
- Social Media
- Whistle Blower

The expectation is these policies will be in approved by Divisions and Clubs by November 1, 2024 or in time for member registration in the 2024-2025 membership year.

### Integrated Club Funding

This is a Club Development grant available to all CCSAM Member Clubs. There are two intake dates: October 15<sup>th</sup> & February 15<sup>th</sup> annually. 80% of the fund will be dispersed after the October deadline with the remaining 20% available in February for clubs that missed the first deadline.

Subject to Sport Manitoba funding, the amount available in this grant program is ~ \$20,000. This funding is available to any CCSAM Member Club. The amount distributed to each applying club will be based on how closely the club programs align with the Four Pillars of Sport Development as defined by our funding partner, Sport Manitoba. These pillars are Sport Initiation, Performance Pathway, Technical Leadership, and Organizational Effectiveness.
